Anglo Belge Special Risks joins forces with the PatrimOne and Eeckman Art & Insurance group

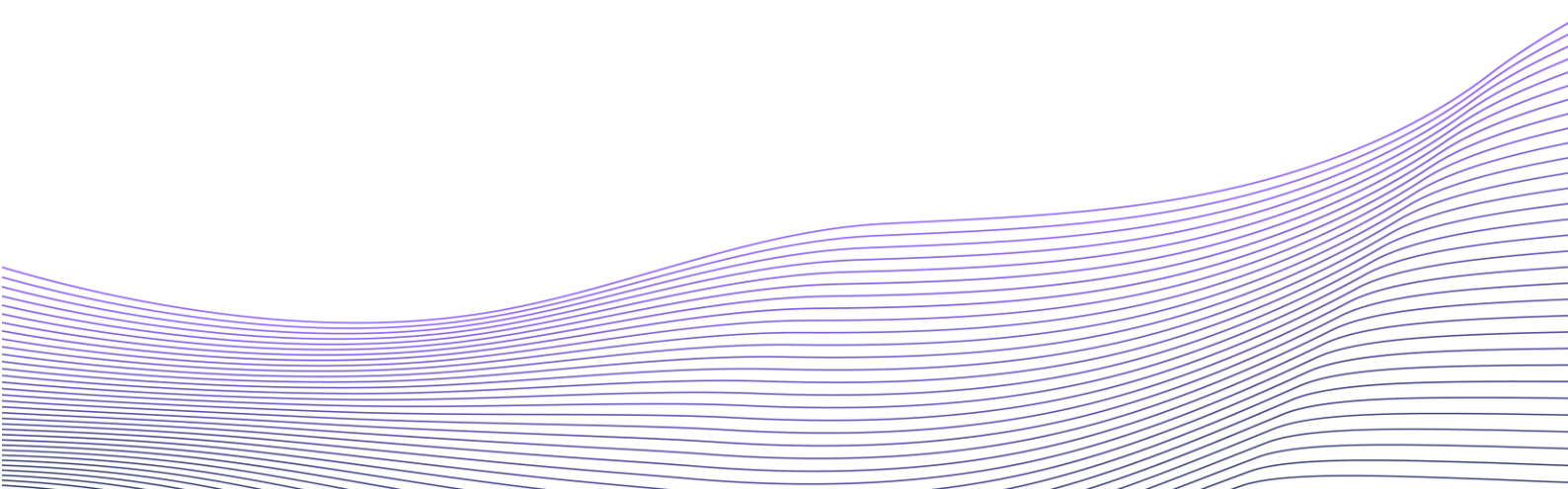
